Reference: Notification of All India Council for Technical Education, New Delhi of Dated 01/07/2009. Point No. 6 (c), (d), (e).

F. No.37-3/Legal/AICTE/2009-In exercise of the powers conferred under section 23 read with Section 10 (b), (g), (p) and (q) of AICTE Act, 1987, the All India Council for Technical Education hereby makes the following Regulations:-

- 1) These Regulations may be called by All India Council for Technical Education (Prevention & Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education) Regulations 2009.
- 2) They shall come into force on the date of the notification.

Anti - Ragging Committee:

The duty of the Anti-Ragging Committee to ensure compliance with the provisions of these regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the Institution.
