F. No.37-3/Legal/AICTE/2009 -In exercise of the powers conferred under section 23 read with Section 10 (b), (g), (p) and (q) of AICTE Act, 1987, the All India Council for Technical Education hereby makes the following Regulations:-

- 1) These Regulations may be called by All India Council for Technical Education (Prevention & Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education) Regulations 2009.
- 2) They shall come into force on the date of the notification.
